# Understanding and assessing young people at risk of violence

This full day workshop will provide participants with an understanding of the risk factors for violence in young people and discuss the implications for assessment and management. # Understanding personality disorders and offending

Forensic mental health increasingly recognises that personality disorders and problematic personality traits are frequently associated with offending in general. With some forms of offending there are more specific associations. Moreover, personality disorder profoundly influences the capacity of mental health services and individual clinicians to engage effectively with clients at risk of offending.

This training provides an overview of the evidence linking personality disorder and offending to help clinicians better understand their clients and how to work with them. This training is suitable for clinicians, service providers, lawyers, and policy makers in the forensic mental health and criminal justice systems.

# Working remotely with justice involved clients: Challenges and opportunities

Workplace restrictions associated with the global COVID-19 pandemic resulted in a dramatic uptake of remote working arrangements for health care providers and practitioners working within correctional services. Although this channel of communication was in use well before the pandemic, particularly within general health and mental health services, forensic practitioners were relatively slow to adopt these practices. The criminal courts had also occasionally expressed concern about practitioners conducting assessments of clients remotely. Many forensic practitioners are now comfortable with remote ways of working and it appears likely that both face-toface and remote ways of working will be used by forensic practitioners into the foreseeable future. This lunchtime workshop explores remote ways of working by forensic practitioners. We will discuss some of their benefits and limitations. Contemporary practice guidelines will be studied and some possible solutions to identified issues, for clients and practitioners, will be considered. At the completion of this workshop, participants should be familiar with ways of working remotely, aware of some of their limits, and able to consider practices that may limit the impact of these issues. This two-hour workshop includes both teaching and group discussion and is suitable for all practitioners involved in the assessment and treatment of justice-involved clients.

# Working with clients who have a dual diagnosis

Dual diagnosis refers to the co-occurrence of serious mental health and substance abuse problems, and is associated with poorer outcomes than mental health or substance abuse problems on their own. Dual diagnosis is also associated with higher rates of offending behaviour, with approximately 74% of patients in Victoria's Forensic Mental Health Hospital (Thomas Embling Hospital) having a substance abuse or dependence disorder across their life-span, and in the Victorian prison system, people with a serious mental illness are much more likely to have a substance use disorder than those without.

This training aims to enhance participants' conceptual understanding of dual diagnosis and the association with offending behaviours, as well as provide practical guidance in regards to how to have collaborative conversations with people about their substance misuse, mental health problems and offending behaviours.

# Assessing suicide and self-harm risk for clients involved in the justice system

Individuals in the justice system are at greater risk of suicide and self-harm, but there is limited discussion of this high-risk population in most training, research, and mental health practice. At the completion of this half-day training, participants should be able to identify risk factors specific to justice-involved populations, understand how justice involvement may contribute to risk, and consider the complexities of managing suicide and self-harm risk in this population. This training will provide participants the opportunity to practice their skills through group activities and reviewing case studies. This training was designed for clinicians who work in general or mental health services or service providers who work with justice-involved clients. Participants should have an understanding of how to assess suicide and self-harm risk prior to attending.

# Working with people who commit sexual offences

Fear, hatred, disgust and banishment dominate societal discourse about those who commit sexual offences. Legal measures to control the risk posed by sexual offenders are expanding. In this context, it is important that practitioners and services understand the research evidence base and best practice in the assessment, treatment and management of those who sexually offend.

This full-day workshop will give attendees an up-to-date detailed and evidence based overview of: the nature and prevalence of sexual offending; theoretical models of sexual offending; the relationship between sexual offending and mental disorders; risk factors, protective factors and risk assessment; managing sexual offenders; pharmacological treatment; psychological treatment; and, online sexual offending.

# Identifying and assessing individuals at risk of grievance-fuelled violence

Violence by lone individuals driven by a perceived injury or injustice can have devastating outcomes. This training provides a theoretical and practical overview of the concept of lone actor grievance-fuelled violence, including lone actor terrorism, the significance of mental illness and the role of clinicians and other service providers in the prevention of targeted violence. The training will enhance awareness of the threat posed by individuals with pathological grievances, radicalisation to violent extremism, and risk management options.

The training is suitable for all mental health practitioners in general, forensic, adult and youth sectors, as well as professionals in justice, education and law enforcement settings.

# Assessment of personality disorder for adults in forensic services

There is a well-documented need for practitioners to have skills in identifying, assessing and providing clinical intervention for people with personality disorders. This workshop will focus specifically on the clinical and psychometric assessment of personality disorders. It will explore what personality and personality disorder is, and how the way clinical assessment of it has changed over time. It will offer an overview of categorical versus dimensional models of personality disorder, in addition to outlining a range of different approaches and tools to aid clinical assessment. Key considerations and challenges for assessing personality disorder will be discussed within the context of forensic services which will also include assessment of personality disorder for the courts.

The workshop will be targeted to clinicians who assess and treat personality disorder as part of their work.

# Formulation of complex and potentially harmful behaviour

One of the most challenging aspects of working in forensic contexts is responding to behaviours that have the potential to cause significant harm (e.g., violence, threats, harmful sexual behaviour, stalking). To work effectively with such clients, professionals need to be able to formulate the client's behaviour; i.e. understand and explain the behaviour and harm potential, and use knowledge this to guide risk management and intervention. Formulation of problem behaviour is particularly important in cases where there are multiple interacting comorbidities and co-occurring biopsychosocial challenges; in client groups with whom it can be difficult to establish a rapport; and in cases where there is a high risk of inconsistent management across agencies and over time.

The aim of this workshop is to teach a method of formulating problematic and potentially harmful client behaviour that goes beyond the application of structured risk assessment guides. The workshop will involve both didactic learning and case study-based practice.

Participants will finish the workshop with a framework for formulation that they can use to understand and communicate about concerning client behaviour, and to shape risk reduction and intervention efforts. This workshop is intended for health and human services professionals who are keen build their ability to work with clients who present with problematic and potentially harmful behaviour towards others.


